A. The following are questions received and Fulton County Schools (FCS) responses for the above-referenced solicitation:

1. RFP page 24, Section V - Item 1 states: "Provide a minimum of three (3) examples of how your firm provided creative and innovative solutions to assist with hazardous material issues involving complex or challenging projects, preferably in the K-12 environment." RFP page 23, Section III Item 3 states: "Provide the name, title, phone number and email address from a minimum of five (5) references from previous clients for which your firm has performed comparable services." Should the 3 examples that are listed in the response to Section V - Item 1 be included among the 5 references listed in the response to Section III - Item 3?
They can be included, but are not required to be. We are requesting 5 references and if 3 of them happened to be associated with create solutions that is ok. At the same time, if your 5 reference aren't related to the creative solution, that's ok too.

2. On RFP page 46, Fee and Payment Schedule Item II - Laboratory/Testing Services, pricing is shown "per hour." Should laboratory and testing services pricing be "per sample"?
